

Stir Crazy Café Artist Guidelines

Dear Artist:

Thank you for your interest in showing your art at Stir Crazy Café. Both individual and group shows are scheduled with artwork rotating on a monthly basis. The following **Artist Guidelines** apply to all exhibits and shows at Stir Crazy:

Commission: Stir Crazy will take a 20% commission on all sales. Payments are made to Stir Crazy directly by the buyer. Stir Crazy, in turn, will deduct 20% and pay the artist within 15 days of the close date of the show.

Opening: Artists are expected to have an evening opening on the second or third Friday of the month to promote their show (6:30 p.m. to 8:30 p.m.). The artist is responsible for all refreshments, announcements and invitations. No alcoholic beverages are permitted without an ABC special use permit.

Promotion: The artist should promote the show and the opening with flyers or postcards or some type of e-announcement (i.e. Evite). Flyers, postcards or posters should be provided to Stir Crazy to promote the show. In addition, Stir Crazy will send an e-announcement to its database.

Hanging: The artist is responsible for hanging the show. The artwork should be hung from the hooks on the picture moulding. The artist is responsible for all hanging hardware. The show's hang date should be arranged in advance with Stir Crazy and should be done after closing hours or during non-peak operating times.

Artwork Approval: Stir Crazy's management reserves the right to cancel any show at any time if the artwork is deemed inappropriate for any reason.
